D. Course Learning Outcomes:

Upon successful completion of the course, the student will be able to:

- 1. Discuss the distribution of the oral health workforce as related to treatment need, demand, utilization, and access to oral health services.
- 2. Summarize public health career options for dental hygienists available independently, through alternative practice settings, and throughout community agencies.
- 3. Differentiate specific types of research studies based upon characteristics in research design, which include epidemiologic studies.
- 4. Analyze current research articles from peer-reviewed journals by examining and evaluating the study's scientific method, statistical designs, results, and stated conclusions.

- 5. Formulate evidence-based decisions that integrate emerging technologies and treatment modalities into total patient dental hygiene care.
- 6. Describe various demographics and current trends affecting public health.
- 7. Relate dental disease prevention strategies such as, school sealant programs, water fluoridation, and topical fluoride modalities, as a means towards community-based oral health.
- 8. Examine the goals, core functions, and levels of government in public health.
- 9. Recognize the major health policy documents that guide public health programming (Healthy People 2030).
- 10. Illustrate the importance of designing community programs based on health literacy, cultural competency, and equitable care.
- 11. Participate in advocacy efforts to advance the profession and support access to oral health initiatives.
- 12. Formulate the purpose, components, design, and resources used in a dental public health education program.
- 13. Evaluate the importance of incorporating assessment, planning, implementation, and evaluation, in public health programs (APIE).
- 14. Assess the oral health needs of the community through data collection methods, quality of resources, and services.
- 15. Construct a community dental oral health service presentation by incorporating key lesson planning components, and comprehensive educational methodologies.
- 16. Evaluate interprofessional practices that address healthcare needs and promote health in local communities.
