This course consists of the study of the history of music in Europe, the Middle East and the Americas and includes a study of the composers, styles, and social contexts of Medieval, Renaissance, and Baroque music from 800 CE to 1750 CE, including musical case studies of colonization in early modern history (1500 CE-1750 CE).

Upon successful completion of the course, the student will be able to:

- 1. Aurally distinguish music of different composers and composing traditions from 800-1750 CE (Goal 2a, 2c, 6a)
- Demonstrate knowledge of stylistic traits of music from the Medieval (800-1400 CE), Renaissance (1400-1600 CE) and Baroque (1600-1750 CE) periods (Goal 2a, 2b, 2c, 6a, 6c)
- 3. Develop and demonstrate listening skills to evaluate and analyze musical masterworks from the Medieval (800-1400 CE), Renaissance (1400-1600 CE) and Baroque (1600-1750 CE) periods (Goal 2a and 6c)
- 4. Analyze, critically assess, and explore cultural values (Goal 6b and 6c) and differences (Goal 2d and 8c) including the effects of colonization
- 5. Express an informed personal reaction to a musical masterwork from 800–1750 CE (Goal 6e)
- 6. Describe and analyze how political, economic, and cultural elements transmitted through states and societies from 800-1800 CE affected compositional styles (Goal 6b and 8a)
- 7. Demonstrate knowledge of cultural, social, religious, and linguistic differences in music composed between 800 -1750 CE (Goal 8b)
