NURSING STUDENT:

Resilience, Purpose, and the Power of Support

In our 2022 annual report, we introduced Diana Chinokoro, a newly accepted nursing student who had just relocated from Zambia with her family. Three years later, Diana's journey continues to be defined by resilience and the support she's found at Normandale Community College.

Her nursing path began during a time of personal upheaval. In December 2022, her daughter underwent life-saving surgery at Mayo Clinic.



Amid the stress and uncertainty, Diana received news that she'd been accepted into Normandale's Nursing Program. "My hard work and sleepless nights studying for prerequisites paid off," she says.

Though she faced a setback in her second semester, Diana successfully appealed and rejoined the program. Now in her third semester, she holds fast to the belief that "delay is not denial." "The most rewarding part of this journey is how I've conquered the challenges, trials, and tribulations," she says. "Through hard work and staying positive, I've come out stronger with an attitude that reminds me I can do it."

Clinical experiences have deepened her sense of purpose. At Masonic Nursing Home, she administered flu shots to residents, and at Presbyterian Homes, she offered support and built meaningful connections. "These experiences gave me a deep sense of satisfaction, knowing I'm making a difference."

"I've been a hardworking, valuable member of my community, at my children's schools, at church, and especially at Normandale.

The support I've received, from awards to food supplies from the Campus Cupboard, has been truly impactful."

Diana credits Normandale's nursing faculty for their unwavering support, and she's especially grateful for the guidance she's received as an international student. "Admissions and Student Services have helped me stay on track and make informed decisions."

After graduation, Diana hopes to become a hospice or wound care nurse, fields inspired by her personal caregiving experiences. "I want to sharpen my skills and knowledge to care for patients at the end of life and those with complex wounds."

Looking back, Diana is proud of her growth and contributions.

DENTAL HYGIENE STUDENT:

Building Trust, One Smile at a Time

Briana Trieu didn't begin her academic journey in dental hygiene, but every step led her there with intention. After starting at the University of Minnesota, the pandemic shifted her path. She began assisting at a family friend's dental practice, a suggestion from her aunt that quickly became a calling.

"I realized I really enjoyed STEM and science," Briana reflects, "but also the relationships, with patients and my team. Educating people and helping them access care they've gone without for years has been incredibly rewarding."

That realization led her to Normandale, where she found a program aligned with her values. "They

care about maintaining their facilities and keeping everything up to date," she says. "They also offer resources beyond the classroom that truly aid in people's learning."

Normandale's dental hygiene program emphasizes comprehensive, patient-centered care, something Briana sees reflected in her clinical experiences. "A lot of my patients tell me they learn more about their oral health here than they do at their regular dental clinics."

"It reminds students like me, who return to school in adulthood, that their hard work matters. It pays off when you put in the work."

Scholarships have also played a key role. The Metro Dentalcare/Heartland Dental Hygiene Endowed Scholarship and the Normandale Foundation Returning Adult Scholarship helped ease the cost of materials and board exam prep. "It's lifted some financial burdens," she says. "I can spend more time studying and less time worrying."

As she prepares to graduate in May, Briana is excited about Normandale's upcoming Center for Interprofessional Education in Healthcare. "I'd love to see collaborative outreach where patients receive

both dental and primary care in one appointment."

She hopes donors understand the impact they make.

Her goals are simple but powerful: to be a great hygienist, build lasting relationships, and provide individualized care with empathy.

SIRTIFY® SPOTLIGHT:

Chase Coleman's Journey

When Chase Coleman reflects on his junior high experience, he remembers the teachers who made a lasting impact, and now, he's focused on doing the same. After three years as a paraprofessional and then as a behavior specialist at Valley View Junior High School in Bloomington, Chase saw firsthand how meaningful it is to connect with students during a critical time in their development.

"In my head, that age group is a critical time for people trying to figure out who they are going to become," says Chase. "If I can have an impact on that, it would be amazing."

Budget cuts pushed Chase back into a paraprofessional role but also motivated him to pursue a teaching degree and licensure through the Normandale Sirtify® program, which aims to diversify the state's teacher workforce. Outside the classroom, Chase continues to mentor youth as a Sunday school teacher and youth minister at

Zion Baptist Church in North Minneapolis, building relationships and life skills that extend far beyond school walls. All these amazing experiences have led Chase to Sirtify[®]. He believes having a program like this is important for so many reasons.

"It is great to be part of a program that helps encourage Black males who are working with students to get a degree and open up their career options in the field."

"Sirtify® not only gives you the education to get
your degree, but through the cohort you
have an opportunity to collaborate, bring
different things to the table, and learn
from each other, which I think will
be great. It creates a strong support

NURSING STUDENT: Early Start, Big Heart

From the moment she meets someone, Halle's heart is "on fire" for them. That instinctive empathy, shaped by personal loss and a close-knit family, has guided her toward a career in nursing and a life of service.

"I see the good in people right away," she shares.
"I lost my brother, grandma, and grandpa all in one year. Seeing the care they received was life changing. It showed me how powerful good healthcare can be, and I want to be part of that difference."

Halle's journey began early. As a high school junior, she enrolled in Normandale's Post-Secondary Enrollment Option (PSEO) program, earning 32 college credits before graduation. That head start allowed her to dive into prerequisites and enter the nursing program as a sophomore.

"Normandale is so accommodating and kind. It's pretty awesome to have a school that's rooting for you. I love that it's on a smaller scale, my professors really focus on me and my learning."

She's found inspiration in the nursing faculty, who bring both clinical experience and deep compassion to the classroom. "They're all nurses themselves, they get us, and they're in the same spot we want to be in."

Halle's path has also been shaped by the De Oliveira Nursing Scholarship, which she says has lifted a major burden. "It's truly a privilege," she says. "I can focus more on my nursing skills and who I'm becoming as a nurse, and less on financial stress."

She hopes donors know the depth of their impact. "It's impacting lives in the most loving and kind way."

Looking ahead, Halle is excited about Normandale's upcoming Center for Interprofessional Education in Healthcare, opening in August 2026. "It's going to bring together the healthcare family. It helps you

build relationships and gain perspectives on working alongside other professionals. It pushes you to be the best version of a nurse you can be."

With empathy as her guide and support behind her, Halle is well on her way to becoming the kind of nurse every patient hopes to meet.

In 2006, Dan returned to Normandale through the business cohort program, graduating in 2008. The cohort model provided connection and motivation. "Having a group of folks you could connect with the whole time was fantastic," he says.

What began as a practical choice became transformative. "I knew I could check off

A LEGACY OF GIVING:

Julie Guelich's Enduring Impact at Normandale

Julie Guelich's journey with Normandale Community College began in the classroom. As a graduate student in mathematics at the University of Minnesota, she started teaching part-time at Normandale and quickly felt at home.

"I had a mentor in college when I was a student in undergrad that thought that community colleges were really the wave of the future," Julie says.

Her career grew from part-time faculty to department chair, Dean of STEM, and eventually Vice President of Academic Affairs, a role she held for over a decade. "One of the wonderful things about the position was that I could sit in on classes from a lot of different departments," Julie says. "I got to know faculty a lot better, and I got to know students who were studying in different areas."

Among Julie's proudest accomplishments is the Academy of Math and Science (AMS), created in partnership with the Normandale Foundation. "I called it a three-legged stool," she explains. "Advising, peer support, and financial assistance, each leg helped students focus more on learning and less on financial stress."

The impact continues through AMS alumni who now mentor current students. "Many of the alums of the Academy of Math and Science have a really positive feeling about the support they received while they were students," Julie says. "They were happy to mentor some of the current students."

Her legacy also lives on in the Math Center, now named in her honor. "It was such an honor when I retired to learn they named the Math Center after me. It was a total surprise," she says. "I'd always enjoyed working with students in the Math Center."

Even in retirement, Julie continued to give back as a dedicated donor and member of the Foundation Board, a role she recently exited after serving two

three-year terms. "When I retired, I wanted to stay connected with the college," she says. "I felt that I had knowledge of the various programs and degrees and knowledge about faculty and staff that maybe could help support the work of the Foundation."

A steadfast supporter since 1986, Julie has made an extraordinary impact through nearly four decades of giving, championing AMS, academic travel programs, math scholarships, and the annual fund with remarkable generosity.


Julie believes deeply in community engagement and the importance of philanthropy. "People need to understand that while we are fortunate to have state funding for the college, it doesn't cover all of the costs we need to educate students," she says. "The more we can involve people outside the college, the better."

Looking ahead, she's optimistic about Normandale's future. "I think, over the years that I've been involved with Normandale, the community at large has seen what a gem the college is," Julie says. "I would say what excites me is that Normandale will continue to grow, continue to change, and meet the needs of our student population."

A Voice for Families: Kimberly's Path Forward



While working as a paraprofessional at Centennial Lakes Elementary in Richfield, Kimberly Hernandez Xochipiltecalt realized she wanted more; more connection with families, more tools to support students, and more opportunity to make a lasting impact. Unsure where to begin, she found her path through the SpedUP program at Normandale.

"Before SpedUP, I wasn't sure I could do college," Kimberly shared. "I didn't know what to do or if I'd have the support. But everything was structured perfectly, it took a lot of the stress away."

With guidance from advisors and a clear roadmap, Kimberly earned her associate degree and walked in Normandale's Commencement Ceremony in May. She's now continuing her education at Minnesota State University, Mankato, with plans to earn both her bachelor's and master's degrees in special education.

Her goal is to be a voice for families navigating the special education system and to ensure every child receives the support they need. "There are so many kids who need us now and in the future. We're the ones who will make the impact and it's important we work through any obstacles to be there for them."
